"Following the Oral report presented by the Chairman of the Committee of Governors at the Informal meeting of the EEC Ministers of Finance at Gleneagles, the Committee invites the group of experts under their Chairmanship of Mr. Dalgaard to examine the possibilities for bringing the official and private ECUs closer together, with particular reference to the proposals already put forward to the Italian and French delegations."
