Fast-track detailed assessment anget T2-0147-SYS

On 24 February 2025 T2WG requested the fast-track detailed assessment of the Change Request:

• T2-0147-SYS Upgrade of T2 messages to ISO MR 2025

On 4 April 2025 T2WG requested to assess an earlier delivery of RTGS core payment messages for user testing (T2 UTEST). This caused an extension of the then far progressed CR DA.

4CB fast-track detailed assessment showed that the Change Request could be implemented in **T2 R.2026.NOV** following the deployment path:

On 05 June 2025 the T2-WG requested the 4CB to perform the detailed reassessment of CR T2-0147-SYS

The re-assessment should reflect the following revised requirements:

- Seven core payment messages (pacs.002, .004, .008, .009, .010, camt.029 and camt.056) in T2 RTGS shall remain in ISO MR2019 in November 2026 and should be excluded from CR-0147
- Non-binding UGs for the remaining messages which are to be upgraded due to ISO MR2025 are to be published in March 2026 to allow market participants sufficient time to make necessary adaptions on their end prior to T2 R2026.NOV.

4CB will provide the result of the detailed re-assessment by 04 July 2025
