### EURO AREA SECURITIES ISSUES STATISTICS: APRIL 2013

*The annual rate of change of the outstanding amount of debt securities issued by euro area residents was -0.3% in April 2013, compared with -0.2% in March. For the outstanding amount of quoted shares issued by euro area residents, the annual growth rate was 0.3% in April 2013, compared with 0.5% in March.*

New issuance of debt securities by euro area residents totalled EUR 835 billion in April 2013. Redemptions stood at EUR 880 billion and net redemptions amounted to EUR 23 billion.<sup>1</sup> The annual rate of change of outstanding debt securities issued by euro area residents was -0.3% in April 2013, compared with -0.2% in March (see Table 1 and Charts 1 and 3).

The annual rate of change of outstanding short-term debt securities was -9.2% in April 2013, compared with -9.1% in March. For long-term debt securities, the annual growth rate was 0.7% in April 2013, compared with 0.8% in March. The annual growth rate of outstanding fixed rate long-term debt securities was 3.7% in April 2013, compared with 3.6% in March. The annual rate of change of outstanding variable rate long-term debt securities was -7.7% in April 2013, compared with -7.5% in March (see Table 1 and Chart 3).

As regards the sectoral breakdown, the annual growth rate of outstanding debt securities issued by non-financial corporations was 12.2% in April 2013, compared with 12.4% in March. For the monetary financial institutions (MFIs) sector, this rate of change was -5.9% in April 2013, compared with -5.8% in March. The annual rate of change of outstanding debt securities issued by financial corporations other than MFIs decreased from -0.9% in March 2013 to -1.5% in April. For the general government, this growth rate was 3.2% in April 2013, the same as in March (see Table 2 and Chart 4).

The annual rate of change of outstanding short-term debt securities issued by MFIs was -18.2% in April 2013, compared with -18.6% in March. The annual rate of change of outstanding long-term debt securities issued by MFIs was -4.1% in April 2013, compared with -3.9% in March (see Table 2).

Concerning the currency breakdown, the annual rate of change of outstanding euro-denominated debt securities was -0.6% in April 2013, compared with -0.5% in March. For debt securities in other currencies, this growth rate decreased from 2.6% in March 2013 to 2.3% in April (see Table 1).

New issuance of quoted shares by euro area residents totalled EUR 3.6 billion in April 2013. Redemptions came to EUR 5.9 billion and net redemptions amounted to EUR 2.3 billion. The annual growth rate of the outstanding amount of quoted shares issued by euro area residents (excluding valuation changes) was 0.3% in April 2013, compared with 0.5% in March. The annual growth rate of quoted shares issued by non-financial corporations was 0.1% in April 2013, the same as in March. For MFIs, the corresponding growth rate decreased from 2.2% in March 2013 to 0.9% in April. For financial corporations other than MFIs, this growth rate was 2.7% in April 2013, compared with 2.6% in March (see Table 4 and Chart 6).

The market value of the outstanding amount of quoted shares issued by euro area residents totalled EUR 4,726 billion at the end of April 2013. Compared with EUR 4,068 billion at the end of April 2012, this represents an annual increase of 16.2% in the value of the stock of quoted shares in April 2013, up from 9.2% in March.

*Unless otherwise indicated, data relate to non-seasonally adjusted statistics. In addition to the developments for April 2013, this press release incorporates minor revisions to the data for previous periods. The annual growth rates are based on financial transactions that occur when an institutional unit incurs or redeems liabilities, they are not affected by the impact of any other changes which do not arise from transactions.*

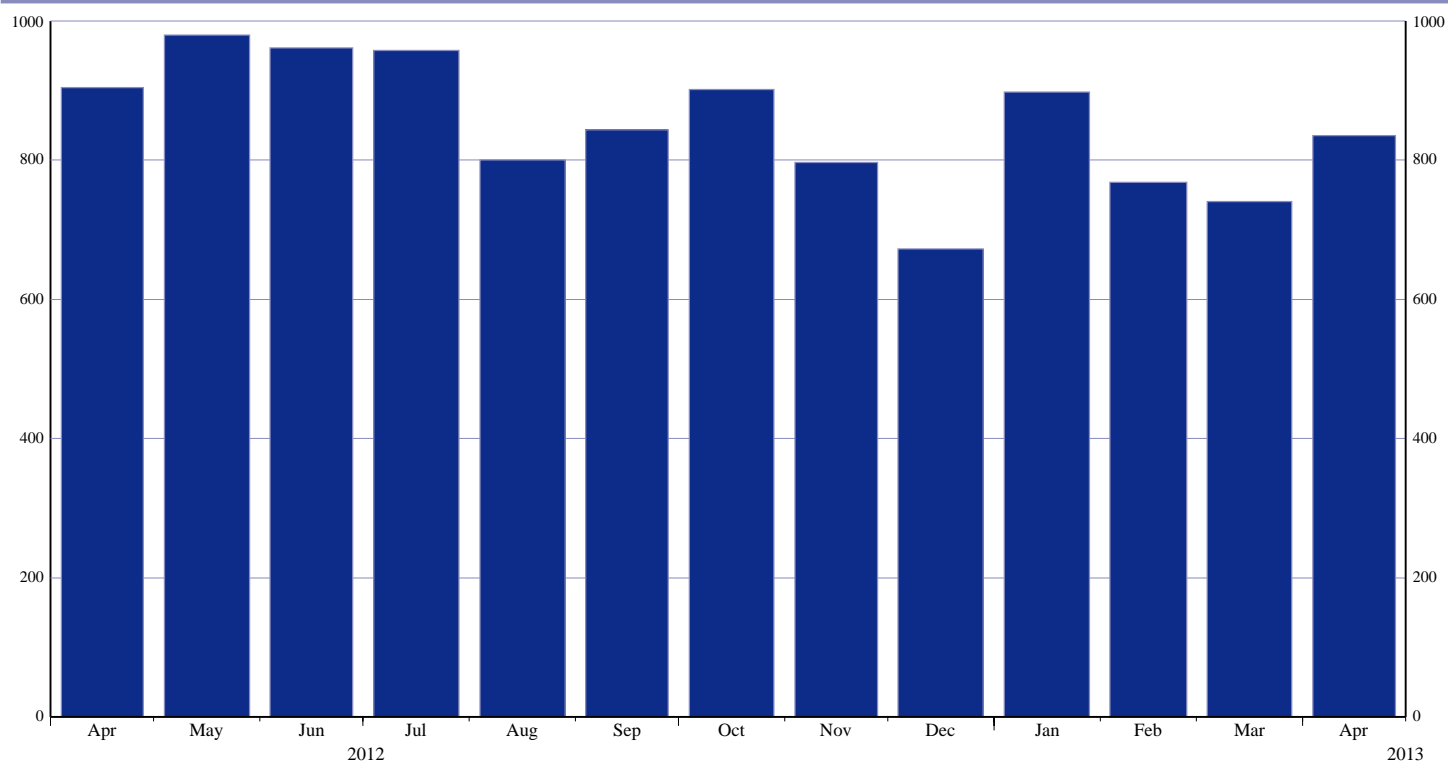

(EUR billions; transactions during the month; nominal values; seasonally adjusted)

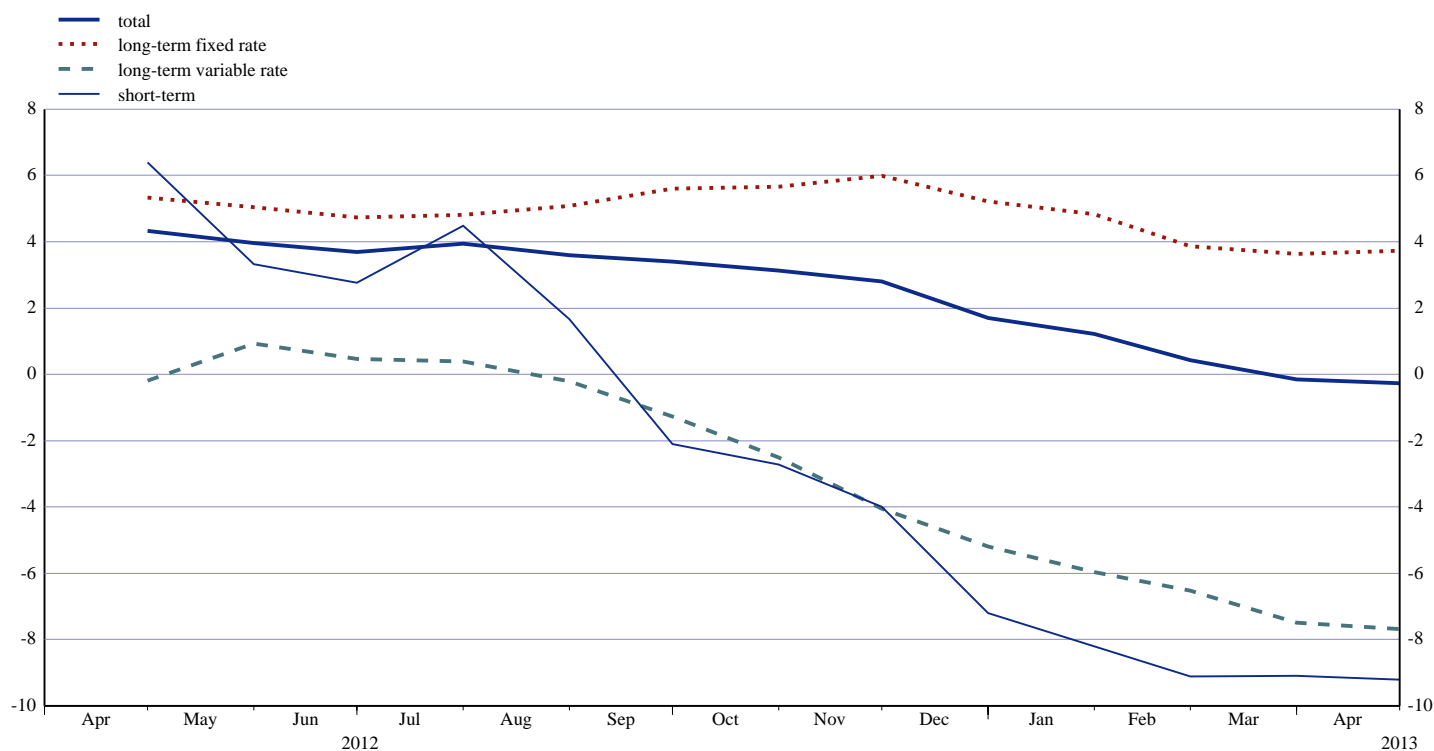

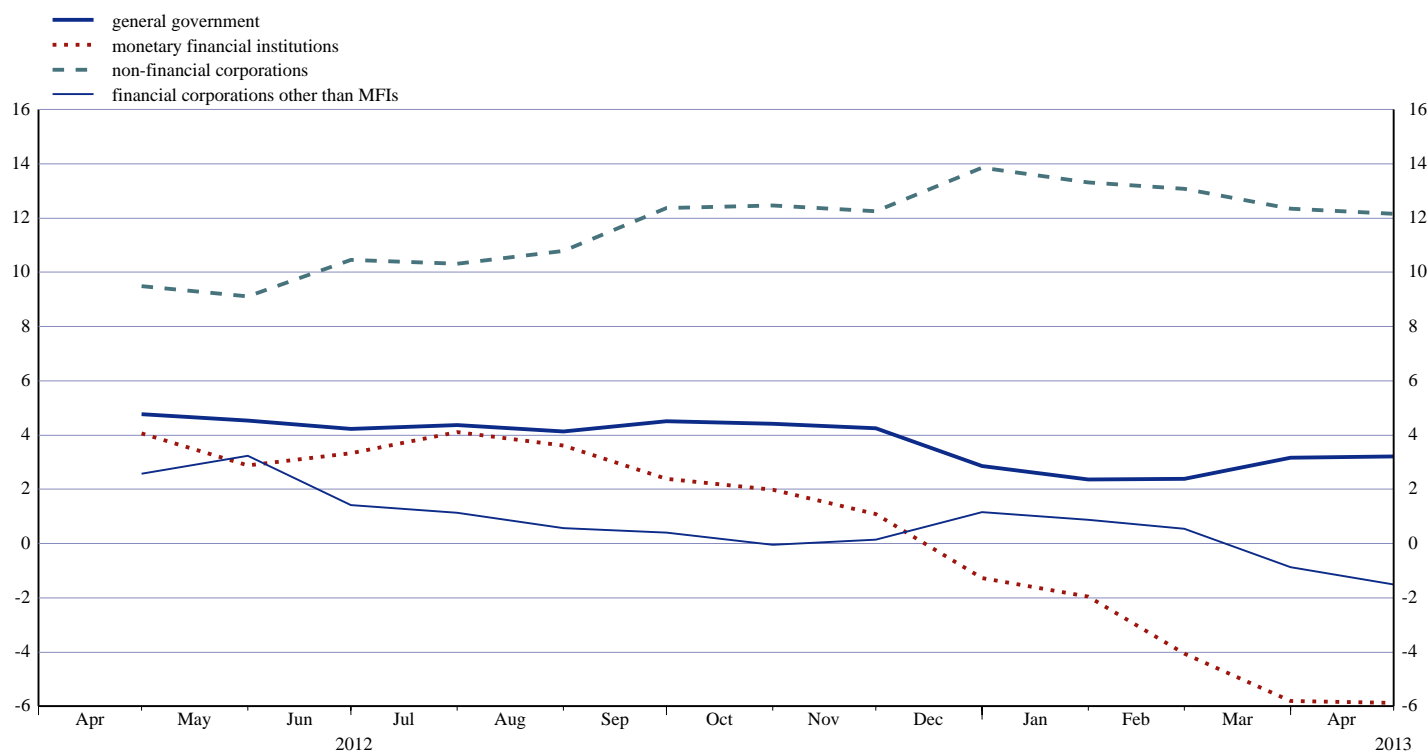
**Chart 3: Annual growth rates of debt securities issued by euro area residents <sup>1)</sup>, by original maturity**

(percentage changes)



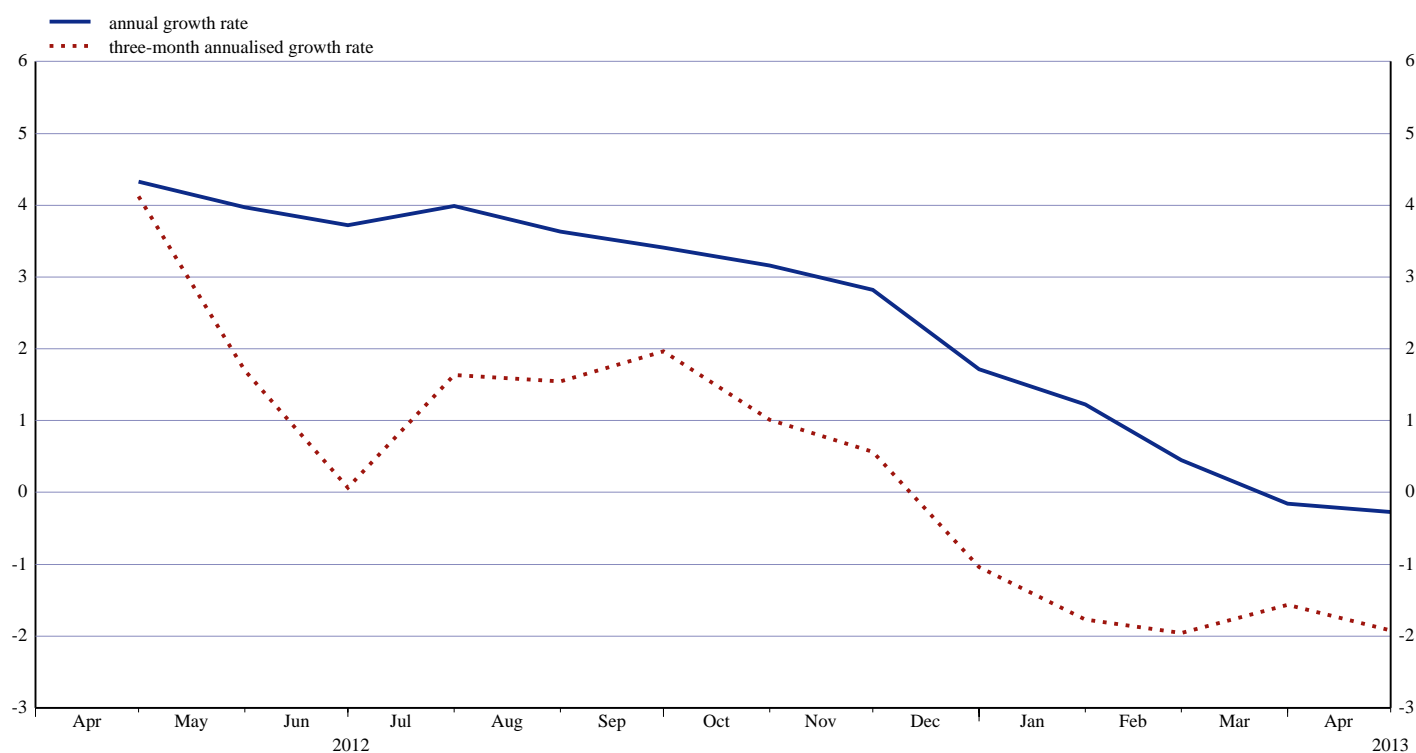

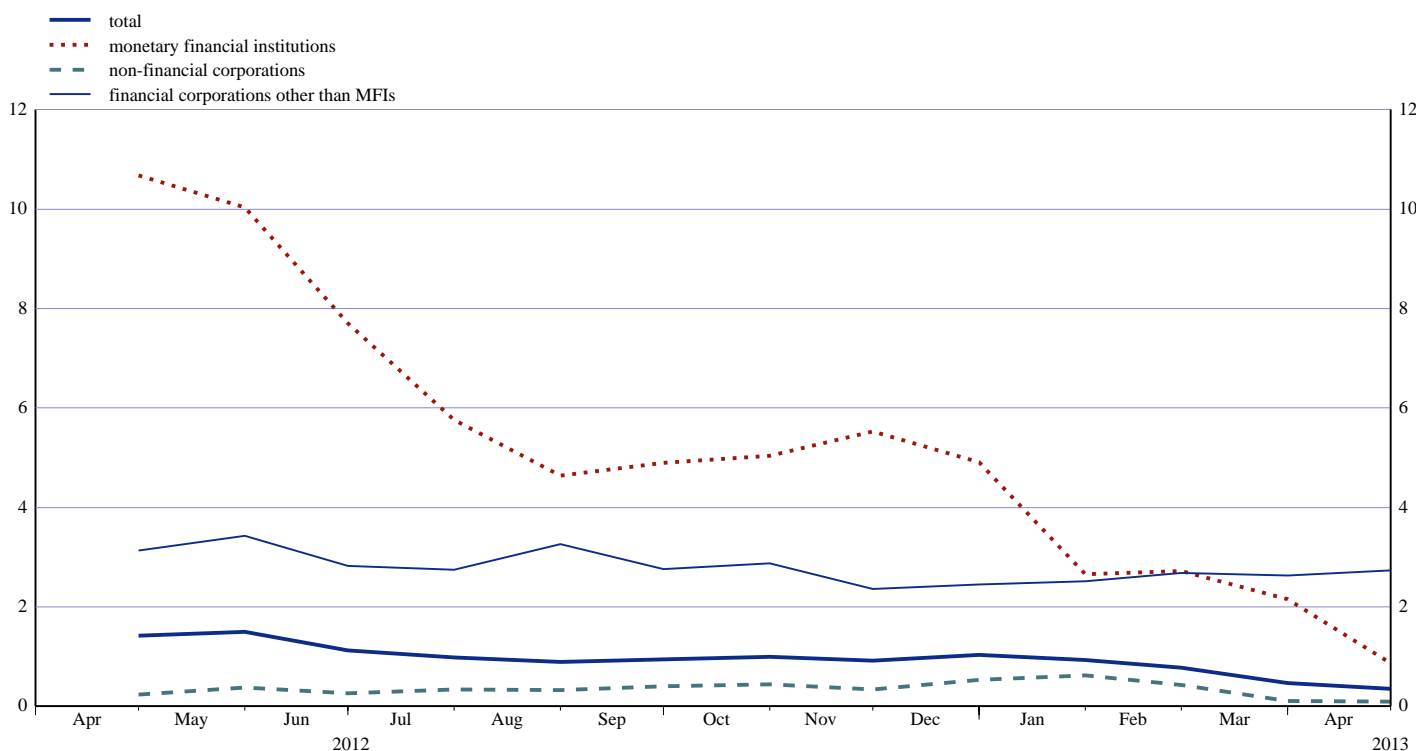
**Chart 5: Growth rates of debt securities issued by euro area residents <sup>1)</sup>, seasonally adjusted**
